



**APPLICATION REGULATION FOR UKRAINIAN CITIZENS  
AND THIRD-COUNTRY NATIONALS OF THE EUROPEAN  
UNION COMING FROM RECOGNIZED HIGHER  
EDUCATIONAL INSTITUTIONS  
IN UKRAINE**

The application regulations for the study programs within the University of Medicine and Pharmacy of Craiova are elaborated in accordance with:

- The provisions of the National Education Law no. 1/2011 with subsequent amendments;
- *Address of the Ministry of Education no. DGRIAE-474 / CMJ / March 3<sup>rd</sup> 2022;*
- *OMEC 4151 / 24.04.2020 amending the Order no. 3473/2017 on the Methodology of admission to studies and schooling of foreign citizens starting with the school / university year 2017-2018;*
- *OMEN 3473/17.03.2017;*
- *OMEC 4241/2020;*
- *Methodology regarding the recognition and equivalence of studies or periods of study abroad UMFCV 2020;*
- *OMEC 4205/2020.*

**WHO CAN APPLY?**

1. Ukrainian citizens enrolled in university studies at one of the higher education institutions in Ukraine recognized by the Romanian state.
2. Third-country nationals of the European Union coming from recognized higher education institutions in Ukraine.

**REGISTRATION STAGES:**

1. The candidate will apply to U.M.F. of Craiova by accessing the online platform, fill in all the fields with the requested information and upload all the mentioned documents.

Please make sure that:

- all documents are scanned in **PDF format only**, and the name of the document must include the type of document and the last name of the candidate (passport.Smith, transcript.Smith, etc.).

- use a **valid email address with your first and last name**.

2. Files submitted online by candidates will be processed by the International Relations Office.

If the file is complete, the candidate will receive a validation notification via the platform.

If the file is incomplete, the candidate will receive a correction notification via the platform to upload the missing documents or to change the incorrect and incomplete fields.

**3.** The University of Medicine and Pharmacy of Craiova will send the eligible files of the candidates to the Ministry of Education - General Directorate of International Relations and European Affairs in order to obtain the letters of acceptance. After confirmation of acceptance for studies, in approximately 30 working days, the method of sending the letter of acceptance will be decided by mutual agreement.

**Registration will be possible only after the issuance of acceptance letters by the Ministry of Education.**

**Candidates who do not upload by **June 24, 2022** all documents in accordance with this regulation will be declared rejected.**

**The admission process is conditioned by the promotion of an English language test organized by the University of Medicine and Pharmacy of Craiova according to its own methodology. Details regarding the date, the manner of its conduct and the participation fee will be established in the meeting of the UMFCV Senate and will be published on the university website.**

The enrollment in the senior year of those who request the equivalence of studies is carried out by the decision of the rector of UMFCV, on the with fee places, with the fulfillment, beforehand, of the following cumulative conditions:

- Recommendation of the CRID (Information and Documentation Resource Center) of the university, following the evaluation of the file by the specialized commission (equivalence), in the corresponding academic year, evaluation that will be performed only after the registration of the respective candidate following the documents issued by the Ministry of Education;
- Respecting the schooling capacity for each study program.

The recognition of study periods and the granting of the corresponding credits is done by CRID, at the proposal of the specialized (equivalent) commissions at the level of each faculty.

**Residence in Romania during studies**

Non-European citizens must obtain a study visa, issued by the Romanian Embassy in the country of residence. The visa is issued on the basis of the Letter of Acceptance, issued by the Ministry of Education - General Directorate for International Relations and European Affairs and on the basis of the payment of the tuition fee for one academic year. The study visa is valid for 90 days, during which the candidates are obliged to obtain the residence permit in Romania, issued by the Immigration Service of Dolj County – no. 32-34 Amaradia Street, Craiova.

**Apply for study visa as soon as you receive the Letter of Acceptance!**

**MANDATORY DOCUMENTS FOR THE REGISTRATION PROCESS:**

1. **[Request for the letter of acceptance for studies](#)** (filled, dated and signed, with photo attached) - **1 color scan copy**;
2. **Europass CV** (dated and signed on each page) - **it is mandatory to include your personal email and phone number**;
3. **Receipt of payment** of the file processing fee;
4. **Motivational essay** in English - maximum 400 words (dated and signed on each page);
5. **Certificate of language proficiency - English, minimum level B2** issued by an accredited institution - **1 color scan copy**;

**Exception:**

- citizens of countries where the official language is English;
- citizens who have graduated high school in an educational institution where the language of instruction is English, confirmed by presenting a certificate attesting to this;

6. **High School Diploma – 1 color scan copy** (certified as authentic by a notary) and **1 translation in Romanian** (certified as authentic by a notary);

Depending on the country the high school diploma was issued in, it must be authenticated with **the Hague Apostille** or **super legalized** by:

- Ministry of Foreign Affairs of the issuing country;
- Embassy / Consular Office of Romania in the issuing country.

**Important!** It might be necessary for you to submit additional documents beside your high school diploma - if you do, please upload **1 color scan copy** (certified as authentic by a notary) and **1 translation in Romanian** (certified as authentic by a notary).

You can check all the information in the list above.

**If the name and surname of the candidate on the high school diploma are not identical to the name and surname appearing on his/her birth certificate or passport, the candidate is required to submit a notary statement that certifies that he/she is the legal holder of the diploma.**

- 7. Transcript of Records** for each high school year of study – **1 color scan copy** (certified as authentic by a notary) and **1 translation in Romanian** (certified as authentic by a notary);
- 8. Other documents-** in order to maximize your score (e.g. diploma from another university in the medical or non-medical field, medical volunteer certificates - maximum 2);
- 9. Birth Certificate** – **1 color scan copy and 1 translation in Romanian** (certified as authentic by a notary);
- 10. Passport - 1 color scan copy** - valid at least six months after the date when the certificate of recognition of high school studies was issued by the Ministry of Education of Romania and a document attesting the residence abroad (**obtained from the City Hall / Prefecture of the city of residence**);
- 11. Medical certificate and psychological exam translated into Romanian - 1 color scan copy** - must contain information on possible chronic diseases of the candidate, signed and stamped by the family doctor / specialist;
- 12. 6 passport size photos - when submitting the original file.**

**Registered candidates, whose files will be declared eligible, will be contacted via the email address provided and will send, within 10 working days, the following documents:**

- 1. Supplement Statement** - attesting to the school situation for the years of study completed, containing: subjects, grades, number of credits / number of points, number of class hours for each subject, issued by the higher education institution the applicant comes from - **1 color scan copy** (certified as authentic by a notary) and **1 translation into Romanian** (certified as authentic by a notary);
- 2. Analytical program** - the content of the subjects studied in the higher education institution the applicant comes from - **1 color scan copy** (certified as authentic by a notary) and **1 translation into Romanian** (certified as authentic by a notary);

**3. Declaration on own responsibility - 1 translation into Romanian** (certified as authentic by a notary); that previous studies have not been interrupted as a result of expulsion due to violation of the provisions of the code of ethics and deontology of the home university.

**4. Official certificate showing the grading system applied in the institution where he / she studied, as well as its equivalence in the European Credit Transfer System (ECTS system) - 1 translation into Romanian** (certified as authentic by a notary).

**THE SELECTION PROCESS**

**I.** The analysis of the submitted files will be processed by the Admission Commission in the order of receiving the files. The existence of an eligible file does **NOT** imply the actual enrollment in the first year of studies.

**II.** The selection of candidates will be made in descending order of the score obtained, according to the selection criteria mentioned below.

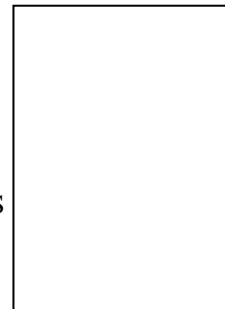
